[Mahoning Adult Protective Services](#) - Adults are sometimes in danger of harm, unable to protect themselves, and have no one else to assist them. We reduce or remedy conditions causing endangerment to adults, maximizing the adult's independence and self-direction, and preventing unnecessary institutionalization. All reported cases of abuse of adults over the age of 60 are confidential. They are investigated and reviewed. Adults are offered support for protection and self-sufficiency, such as homemaker and case management services when funding is available.
